- ✓ **MUST BRING ALL OF YOUR 2019 TAX STATEMENTS & 1099 DOCUMENTS WITH YOU**
- ✓ **COPY OF 2018 COMPLETED FEDERAL AND STATE INCOME TAX & PTR**
- ✓ **CAPITAL GAINS!! – LIMITED TO 5 LINES**
- ✓ **LANDLORDS: WE CANNOT PREPARE FORMS FOR "RENTAL INCOME"**
- ✓ **LOW TO MODERATE INCOME TAX PAYERS**
- ✓ **SENIOR CITIZENS PREFERRED**
