

**TOWNSHIP OF WOODBRIDGE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM  
SUBSTANTIAL AMENDMENT OF 2022 AND 2024 ANNUAL ACTION PLANS**

**Introduction**

The Township of Woodbridge proposes to amend several previous Annual Plans to close one project and fund two projects. Specifically, the Township has created this Substantial Amendment for Program Years 2022 and 2024.

**Revised Activities and Funding Reallocations**

In accordance with CDBG program regulations, the Township is allowed to make substantial amendments to its Annual Action Plan and Budget in accordance with the Township’s Citizen Participation Plan.

Woodbridge has determined that it is necessary to amend the approved CDBG program budget for the previously approved program years FY 2022 and 2024. This is considered a substantial amendment in accordance with Woodbridge’s Citizen Participation Plan as the following applies: a) Adding or dropping an activity and b) increasing the budget of an existing activity.

The amendments proposed are as follows:

This document will be available to the public for a period of thirty (30) days until June 19, 2025, after which time the Substantial Amendment will be considered by the Township Council for submittal to HUD for approval. A Public Hearing on the Amendment will be held on June 3, 2025, at 5:00PM at the Township Municipal Building, 1 Main Street, Woodbridge, New Jersey. Interested parties may attend the hearing and
