SENIOR ART SHOW RULES

ANNUAL WOODBRIDGE TOWNSHIP SENIOR ART SHOW

At the BARRON ARTS CENTER

ELIGIBILITY: Any artist (painter, sketcher, graphic artist) age 60 or over currently residing in Woodbridge, may submit three (3) entries completed within the last three years. Art that has been in previous art shows will not be eligible for judging. Entrants may be of either professional or non-professional status. There shall be no attempt to limit entrants to just professionals or non-professionals.

CLASSIFICATIONS: Non-professional - Persons claiming non-professional status must not have (1) Sold the types of art entered in the contest/exhibition through commercial channels; (2) Exhibited in a professional gallery; (3) Ever had a membership in a professional artist guild.

Professional - Persons claiming professional status are those who have (1) Sold the type of art entered in the contest/exhibition commercially; (2) exhibited professionally; (3) held membership in a professional artist guild or association.

ART WORK: All work must be the original creation of the artist; mounting, matting and framing excluded.

No kit paintings or craft kits, photographs/copies of others' original art work will be accepted.

CATEGORIES: The following are categories of eligible work:

1. Oil
2. Acrylic
3. Watercolor- including gouache
4. Pastel
5. Print- including etching, dry point & itaglio
6. Drawing-including pencil, pen, ink, graphite, chalk and charcoal
7. Mixed Media - including collage
8. Photography
9. Sculpture
10. Fine Crafts (no craft kits accepted)

****All 2-D pictures are to be delivered “show ready” - matted, mounted, and ready for hanging.****

All 2-D work is to be framed with screw eyes and wire for hanging. While all possible care will be taken to safeguard the art work, The Woodbridge Township, Division on Aging, or the Barron Arts Center will not assume the responsibility for loss or damages incurred, however, the municipality does have insurance that covers the value of the works. Precautions for protection by proper packaging of the work for handling should be taken by the artist.

All art work submitted must be properly labeled. Entry form sheets must be attached securely to the back of each picture, completely filled out. Please attach your name on any bags you use to carry your art work in.

DELIVERY: Art work must be delivered to Evergreen Senior Center, 400 Inman Avenue, Colonia or the Barron Arts Center 582 Rahway Avenue Woodbridge by April 16th.

PICK –UP: Art work can be picked up after the show on April 30 (**NO EARLIER THAN 8pm**) or on May 1-3 at the Barron Arts Center. If art was registered at Evergreen, Sycamore or 5 Branches Senior Center, art will be returned to the appropriate senior center and available for pick-up starting May 6.

NOTICE: **All art work exhibited must remain until the completion of the show on Tuesday, April 30th.**
